**Re: 2017 EOC Continental Programme - NOC Activities- Special Activities**

Dear Friends,

We have pleasure in advising you of the criteria regarding the distribution of the funds according to the EOC/Olympic Solidarity Continental Programme within the framework of the NOC Activities.

Regarding the annual subsidy granted for “**NOC Activities**”, the lump sum to be distributed to all 50 European NOCs is

**USD 100,000**

The NOCs that have sent in the **Financial Report** (using the appropriate form) for the amount received in **2016** are entitled to receive this sum.

The detailed **Financial Report for 2017** must be sent in by **31<sup>st</sup> March 2018**.

NOCs that do not comply **will not be considered for any funding** under Special Activities and the Annual Subsidy (USD 100'000) will thus also be forfeited.

Regarding the “**Special Projects and Activities in favour of NOCs**” Programme, the EOC will provide financial support to European NOCs with special needs to enable them to implement a specific activity during 2017, as detailed in the **Explanatory Note** below.

Please note that as of 1<sup>st</sup> January 2013 the EOC Olympic Solidarity Continental Office has adopted the financial monitoring system, as instructed by the Olympic Solidarity Lausanne Office.

## Quadrennial Plan 2017-2020

### -- EXPLANATORY NOTE --

#### NOC ACTIVITIES

##### A) SUBSIDIES FOR 50 EUROPEAN NOCS

###### Objective

To offer European NOCs financial support for activities such as: preparation for the Olympic Games, training camps, activities within the NOC, including administration provided that this item is not covered under another Olympic Solidarity programme or unless specifically approved by Olympic Solidarity, etc.

###### Conditions

The grants for this programme amount to **USD 100,000** per NOC.

Each NOC may decide how to use this lump sum as per the Programme's Objectives.

###### Deadline

There is no deadline. The NOCs will receive the money without applying for it, provided that they have sent in the Financial Reports for the previous year.

##### B) SPECIAL PROJECTS AND ACTIVITIES IN FAVOUR OF NOCS.

###### Objective

To offer ENOCs assistance for:

**Activities directly or indirectly connected with the Olympic Games** such as:

- organisation of national courses for high level athletes, coaches and sport managers;
- participation of high level athletes in training camps;
- anti-doping measures;
- medical consultations;
- sports equipment and technical material;
- visits to Olympic venues.

**Development of sport**, such as:

- funding for targeted NOCs to create, where needed, simple, functional and economical sports facilities;
- assistance to National Federations (participation of athletes and coaches in competitions, preparatory camps, organization of national championships and events, sports equipment and technical material etc);
- training of judges and referees;
- training and education of sports managers and administrators;
- activities to promote and develop young talented athletes.

*Activities aimed at strengthening the role of NOCs*, such as:

- organisation of specific seminars;
- training courses for leaders and administrative staff;
- Assistance for NOC Commission activities;
- Strategic planning workshops;
- Upgrading technical equipment;
- Seminars, conferences and activities to spread the IOC philosophy in areas such as women & sport, sport and environment, athlete health care, anti-doping awareness campaigns, National Olympic Academy and so on;
- Sport for all activities;
- Promote sports activities and Olympic values within schools and colleges.

NOCs should take special care not to apply for funding for the same activity under both the World and the Continental Programme unless the applications are **complementary**, so as to maximize results for the NOCs and improve coordination between the OS Continental and World Offices.

#### **Conditions**

Each European NOC is eligible to apply for these activities by sending a detailed application directly to the EOC Rome Office. The application should include the programme and the budget and should be compiled using the attached form.

The programme will be managed by the EOC, following due examination and approval of the requests.

Following approval, the NOCs will receive the funds.

#### **Deadline**

There is no deadline. Applications will be accepted until the funds from the annual budget are exhausted.

### **C) FINANCIAL REPORT**

Please note that as of 1<sup>st</sup> January 2013 the EOC Olympic Solidarity Continental Office has adopted the financial monitoring system, as instructed by the Olympic Solidarity Lausanne Office.
